Chief Executive unveils her Maiden Policy Address

The Chief Executive (CE), Mrs Carrie Lam, revealed details of her maiden Policy Address themed "We Connect for Hope and Happiness" at the Legislative Council on October 11, 2017.

In the last two decades, thanks to the support of the Motherland and with an international vision, Hong Kong has kept its distinct features and strengths. This fully demonstrates that "one country, two systems" is the best institutional arrangement to ensure Hong Kong's long term prosperity and stability after our return to the Motherland. It is a workable solution and an achievable goal, she said.

A number of initiatives of interest to the business and international communities:

Economy

- Support SMEs by reducing profits tax to 8.25% for first \$2 million (US\$255,000) profits. Remaining profits to be taxed at current rate of 16.5%;
- Encourage R&D investment with 300% tax deduction for first \$2 million R&D expenditure, and 200% deduction for remainder;
- Increase the number of comprehensive avoidance of double taxation agreements (CDTAs) to 50 within the next few years;
- Sign a Free Trade Agreement (FTA) and an Investment Promotion and Protection Agreement (IPPA) with Association of Southeast Asian Nations (ASEAN) in November; and sign a Closer Economic Partnership Arrangement (CEPA) with Macao by end 2017;
- Open an Hong Kong Economic and Trade Office (HKETO) in Thailand the third HKETO in ASEAN;
- Demolish and redevelop the three government towers in Wan Chai to create a new, integrated wing for the Hong Kong Convention and Exhibition Centre (HKCEC) with 23,000 square metres of convention and exhibition facilities;
- Boost diversified development of tourism sector, including cultural, heritage, green and creative tourism;
- Issue "green bonds" to encourage investment in green projects via HK capital markets;
- Hong Kong Monetary Authority (HKMA) will launch a Faster Payment System in 2018 to promote more diversified and flexible payment products.

Innovation and Technology

- Set aside at least \$10 billion in university research funding to further encourage private companies to increase R&D spend;
- Kick-start a \$500 million "Technology Talent Scheme" to train and pool technology talent;
- Inject \$3 billion into the Research Endowment Fund;
- Use \$2 billion of the Innovation and Technology Venture Fund Scheme to co-invest on matching basis with venture capital funds investing in local tech startups;
- Invest \$700 million to take forward Smart City initiatives, including "smart lampposts"; and develop an intelligent transport system (parking meters, payments, real-time parking information).

Creative Industries

• Inject \$1 billion into the CreateSmart initiative to boost support for design and creative industries.

Labour Rights

- Propose a way forward to abolish the offsetting mechanism for Mandatory Provident Fund contributions;
- Increase paternity leave from 3 to 5 days; and study enhancing maternity leave for working women.

Education

• Set up a \$12 billion Hostel Development Fund to provide unit cost subsidy for university hostels.

Arts, Sports, Culture

 Increase resources for local artists and groups to perform outside Hong Kong.

🗄 Countryside

- Establish a Countryside Conservation Office and earmark \$1 billion to implement revitalisation and conservation efforts;
- The Policy Address also contains a number of new initiatives on land and housing supply, healthcare, care for the elderly and underprivileged, improving livelihood, and youth development.

CE visits ASEAN member states to strengthen closer relations

CE Carrie Lam visited Singapore and Bangkok in August 2017 to foster closer ties between Hong Kong and the two countries.

During her visit in Singapore, CE met with senior Singapore government officials and visited the Asian Civilisations Museum, the Civil Service College, the GovTech Hive, the National Gallery Singapore and the Urban Redevelopment Authority. She also officiated at the opening reception of the photo exhibition "Lee Fook Chee - Son of Singapore, Photographer of Hong Kong" organised by the HKETO in Singapore, in collaboration with The Photographic Heritage Foundation, to mark the 20th anniversary of the establishment of the Hong Kong Special Administrative Region (HKSAR). She also took the opportunity to call on the Chinese Ambassador to Singapore.

In Bangkok, Mrs Lam paid respect to the late King of Thailand and met with senior Thailand government officials, representatives of the business sector to brief them on the latest developments in Hong Kong and to promote the city's trade and investment potentials. She also witnessed the signing of a Letter of Intent between Hong Kong Trade Development Council (HKTDC) and the Department of International Trade Promotion of the Ministry of Commerce of Thailand, attended two CEO roundtable forums on collaboration opportunities, and called on the Chinese Ambassador to Thailand.

CE in Myanmar

Mrs Lam attended the 14th World Chinese Entrepreneurs Convention (WCEC) held in Yangon, Myanmar and delivered a speech at the event. Held in various cities once every two years since 1991, the WCEC aims to provide a platform for Chinese entrepreneurs and the business and industrial sectors from around the world to enhance economic co-operation and understanding.

Mrs Lam also took the opportunity of the visit to meet with senior officials of the Myanmar Government in the capital city of Naypyidaw on September 15. She also conducted visits during her stay in Yangon.

Myanmar is the third ASEAN country visited by the Chief Executive after her assumption of office, reflecting the importance the HKSAR Government attaches to the strengthening of ties with ASEAN.

Mrs Lam said, "Attaching great importance to cooperation with Myanmar as well as other ASEAN members, Hong Kong expects that the Belt and Road Initiative and the development plan of the Guangdong-Hong Kong-Macao Bay Area of China will lead us to a new economic era. With both Hong Kong and ASEAN along the Belt and Road, we hope to co-operate with Myanmar as well as other ASEAN countries to seize the opportunities arising from the Belt and Road Initiative."

CE in Vietnam

CE Carrie Lam in November spoke at the Asia-Pacific Economic Cooperation (APEC) CEO Summit in Da Nang, Vietnam. Accompanied by the Secretary for Commerce and Economic Development, Mr Edward Yau, she hosted a lunch for Hong Kong, China's representatives to the APEC Business Advisory Council (ABAC) to thank them for reflecting the concerns of Hong Kong's business sector in ABAC over the years.

She also attended a discussion session of the APEC CEO Summit on new frontiers in trade and spoke on issues including the impact of globalisation on economic development as well as the rising trend of trade protectionism. Speakers of this session also include the President of Peru, Pedro Pablo Kuczynski, and other business leaders.

HK and ASEAN ink free trade deal and investment pacts

Hong Kong and the Association of Southeast Asian Nations (ASEAN) signed a Free Trade Agreement (FTA) and a related Investment Agreement in Pasay City, the Philippines, on November 12. The agreements will bring about legal certainty and better market access for the trade in goods and services as well as investment protection to Hong Kong. They will also help reduce the restrictions in doing business and expand business opportunities for Hong Kong enterprises, thus creating a more conducive environment for the development of Hong Kong's economy.

The Secretary for Commerce and Economic Development of the HKSAR, Mr Edward Yau, and the economic ministers of the ASEAN member states, signed the two agreements.

"All ASEAN member states are also economies along the Belt and Road. The agreements will extend Hong Kong's FTA and Investment Agreement network to cover all major economies in Southeast Asia. The closer ties forged will enhance Hong Kong's role as a trading and investment hub and cater for our strategy to tap the business opportunities offered by the Belt and Road Initiative," Mr Yau said.

The agreements are comprehensive in scope, encompassing trade in goods, trade in services, investment, economic and technical co-operation, dispute settlement mechanisms and other related areas.

Principal Officials in ASEAN to boost stronger bond

Financial Secretary (FS) in Vietnam

FS Paul Chan attended the APEC Finance Ministers' Meeting (FMM) and related meetings in Hoi An, Vietnam in October. On the sidelines of the FMM, Mr Chan held bilateral meetings with his counterparts, including the Minister of Finance of Thailand, Apisak Tantivorawong; the Undersecretary of Finance of the Philippines, Gil Beltran; the Deputy Minister of Finance of Malaysia, Dato' Lee Chee Leong; and the Under Secretary for International Affairs of the US Department of the Treasury, David Malpass. Mr Chan discussed with them ways to strengthen economic ties and collaboration. The FMM sessions this year focused on a range of subjects, including the latest developments on global and regional economic and financial fronts, investment in infrastructure, work to counter base erosion and profit shifting of enterprises, as well as financial inclusion.

Before attending the FMM, Mr Chan met with the Prime Minister of Vietnam, Nguyen Xuan Phuc, along with other participating finance ministers. Mr Chan also took part in the ABAC's Executive Dialogue to discuss further collaboration with the private sector and various sessions of the APEC FMM.

Secretary for Commerce and Economic Development (SCED) in Vietnam

They had good exchanges on trade-related issues. Both said they believed that the already close economic ties between Hong Kong and the ASEAN member states would further strengthen once the Hong Kong - ASEAN Free Trade Agreement becomes effective. SCED Edward Yau attended the APEC Ministerial Meeting (AMM) in Da Nang, Vietnam in November. He met with various trade ministers and representatives of APEC member economies to have useful exchanges on trade co-operation as well as issues of mutual concern. Mr Yau also had bilateral meetings with the Vice Minister of Commerce, Mr Wang Shouwen; the Minister of International Trade and Industry of Malaysia, Dato' Sri Mustapa Mohamed; the Minister of Economic Development of the Russian Federation, Mr Maksim Oreshkin; the Minister of Trade of Indonesia, Mr Enggartiasto Lukita; the Minister of Foreign Affairs of Thailand, Mr Don Pramudwinai; the Minister for Trade and Export Growth of New Zealand, Mr David Parker; the Secretary of Trade and Industry of the Philippines, Mr Ramon Lopez; and the Second Minister of Foreign Affairs and Trade of Brunei, Pehin Dato Lim Jock Seng. Mr Yau said Hong Kong looked forward to working closely with them in advancing trade liberalisation in various trade fora and fostering even stronger bilateral ties.

Secretary for the Civil Service (SCS) in Singapore

SCS Joshua Law paid an official visit to Singapore in October to get an update on the management and training of the civil service in the Lion City. He paid a courtesy call on Singapore's Deputy Prime Minister and Minister in charge of the Civil Service Teo Chee Hean. He met with Singapore's Head of Civil Service Leo Yip and Permanent Secretary (Public Service Division), Prime Minister's Office Yong Ying-I, to exchange views on the overall management, training and development of the civil service. He also met with the Charge D'Affaires ad interim, Embassy of the People's Republic of China in Singapore, Fang Xinwen. During his stay, Mr Law visited the Civil Service College of Singapore and the Lee Kuan Yew School of Public Policy to learn more about their operation.

Secretary for Food and Health (SFH) in Singapore

SFH Professor Sophia Chan visited Singapore in September to meet officials from the Ministry of Health of Singapore and to learn more about primary healthcare services in the Lion City. In addition, she attended the Temasek Foundation International Asia Leaders Connect 2017 programme, during which participants discussed, among other issues, healthcare policies and services and visited Singapore General Hospital.

Secretary for Financial Services and the Treasury (SFST) in Singapore

The then SFST Professor K C Chan visited Singapore in June to foster closer ties between the two places. Upon arrival in Singapore, Professor Chan had separate meetings with the Minister for Finance of Singapore, Mr Heng Swee Keat, and the Managing Director of the Monetary Authority of Singapore, Mr Ravi Menon. The Secretary was the Guest of Honour and delivered a keynote speech at the gala dinner organised by the HKETO in Singapore to celebrate the 20th anniversary of the establishment of the HKSAR. He also visited the Government of Singapore Investment Corporation, a sovereign wealth fund established by the Singapore Government to manage the nation's foreign reserves, and the Singapore Exchange. Before concluding his trip, he met with prominent figures from the Association of Banks of Singapore over lunch to exchange views on financial issues of mutual interest.

Secretary for Education (SED) in Myanmar

The then SED Eddie Ng in June met with the Union Minister of Education of Myanmar, Dr Myo Thein Gyi, at a bilateral meeting in Yangon, Myanmar. Both sides agreed to follow up on and finalise a memorandum of understanding (MOU) on education co-operation, with a view to providing a foundation for further co-operation on the education front. The Secretary met with leaders of Yangon University of Education to exchange views on teacher training and observed lessons at the university's high school for teaching practice. He also visited the Singapore-Myanmar Vocational Training Institute, which was established in 2016 to provide skilled labour for key industries in Myanmar.

Secretary for Development (SDEV) in Indonesia

From March 1 to 3, the then SDEV Eric Ma led a Hong Kong delegation to visit Jakarta, Indonesia. Speaking at a networking luncheon co-organised by the HKTDC, the Indonesian Chamber of Commerce and Industry, the Indonesian Chinese Entrepreneur Association and Real Estate Indonesia, Mr Ma said Hong Kong has rich experience in infrastructure development and professional services, and can play an active role to further promote the relationship between Indonesia and China to reach new heights under the Belt and Road Initiative.

The delegation paid courtesy calls on the Ministry of Public Works and Housing of Indonesia, the Indonesia-Hong Kong Business Association, the Ministry of National Development Planning of Indonesia and the Indonesia Investment Coordinating Board to exchange views about town planning, infrastructure and real estate development. Members also held discussions with representatives from the local industrial and business sectors as well as Hong Kong business people to learn about the business environment and opportunities for co-operation.

Secretary for Justice (SJ) in Malaysia

From November 6 to 8, SJ Rimsky Yuen, SC, visited Kuala Lumpur, Malaysia to foster stronger ties between Hong Kong and Malaysia and led a delegation comprising some 30 legal and dispute resolution professionals to promote Hong Kong's international legal and dispute resolution services.

In addition to addressing the opening ceremony of "In Style • Hong Kong" symposium organised by the HKTDC, Mr Yuen also gave opening remarks at the thematic session on "Legal Risk Management: Key to International Trade and Investment". He highlighted the importance of legal risk management in modern business practice, for which Hong Kong is ready and able to serve as an international and yet neutral legal risk management and dispute resolution hub with its robust legal regime. Mr Yuen also launched "Hong Kong Live in Kuala Lumpur" presented by the Hong Kong Tourism Board to promote Hong Kong tourism experiences.

Mr Yuen took the opportunity to pay a courtesy call on the Charge d'Affaires ad interim of the Chinese Embassy in Malaysia, Madam Ma Jia. The delegation also met with the relevant Malaysian officials to exchange views on matters of mutual interest and visited the arbitration centre in Kuala Lumpur.

ASEAN ministers and officials visit HK to foster relations

Ministers and professional delegations of Singapore in Hong Kong

In September, CE Carrie Lam hosted lunch for visiting Singapore's Emeritus Senior Minister Goh Chok Tong at the Government House. They reaffirmed the good relations exemplified by the frequent exchanges of visits between the leaders of Singapore and Hong Kong and exchanged views on future development challenges and opportunities facing both cities. Mr Goh also expressed optimism of Hong Kong's future under the "One Country, Two Systems" framework. He was also hosted to breakfast by the Chinese People's Political Consultative Conference (CPPCC) vice-chairman and former CE Tung Chee Hwa.

Also in September, Minister, Prime Minister's Office & Second Minister for Manpower & Second Minister for Home Affairs of Singapore, Mrs Josephine Teo, visited Hong Kong. During the visit, Minister Teo called on the Chief Secretary for Administration, Mr Matthew Cheung and met SLW Dr Law Chi-kwong. Both sides affirmed the longstanding and close cooperation between Singapore and Hong Kong, and highlighted the frequent exchange of visits between officials from both sides to learn from each other in overcoming the common challenges faced by the two places. They also discussed issues of mutual interest including population and manpower.

In June, Dr Amy Khor, Senior Minister of State, Ministry of the Environment and Ministry of Health visited Hong Kong. She met with Professor Sophia Chan, the then Under Secretary for Food and Health, exchanging views on collaborations in healthcare sector and development of community nursing. In June, a delegation from Singapore attended Vocational and Professional Education and Training International Conference in Hong Kong. The delegation comprised representatives from Institute of Adult Learning, Institute of Technical Education and students from polytechnics in Singapore.

In May, a delegation from the 24th Governance and Leadership Programme (GLP), led by Accountant-General of Singapore Ow Fook Chuen, visited Hong Kong. The GLP is a three-and-a-half week full-time milestone programme organised by Civil Service College, Singapore. The delegates visited and received briefings from various organisations, including Legislative Council, Civil Service Bureau, Hong Kong Housing Authority, West Kowloon Cultural District Authority, Hong Kong Federation of Youth Groups, Our Hong Kong Foundation, Hong Kong General Chamber of Commerce and Hong Kong Science and Technology Park.

In April, Deputy Prime Minister and Coordinating Minister for National Security of Singapore, Mr Teo Chee Hean, met with the then CE C Y Leung at Government House to exchange views on issues of mutual concern. Both sides hoped that the two places would strengthen co-operation on all fronts to enhance bilateral ties, and work together to promote the further development of economic and trade co-operation in the region.

Delegation from Myanmar's Parliament in Hong Kong

In June, a delegation from Myanmar attended Dashun Foundation and Belt & Road Global Development Alliance Anniversary Cocktail Reception cum MOU Signing Ceremony in Hong Kong. The delegation comprised Members of Parliament and representatives from trade and industry organisations in Myanmar.

President of the Republic of Indonesia in Hong Kong

In May, the President of the Republic of Indonesia, Mr Joko Widodo visited Hong Kong and met with the then CE CY Leung, who briefed him on the latest developments in Hong Kong and highlighted that the country's Belt and Road Initiative would bring about enormous development potential for Hong Kong and ASEAN countries such as Indonesia.

Mr Leung also thanked the Indonesian Government for their support towards assisting the establishment of the HKETO in Jakarta. He hoped that the two places would continue to maintain exchanges and build stronger ties on all fronts.

Mr Leung and the President witnessed the signing ceremony of the Memorandum of Understanding on cultural co-operation which aimed at fostering exchanges in culture and arts and strengthening people-to-people ties between the two places, as well as the signing of a joint statement on labour co-operation which underlined both sides' commitment to protecting Indonesian domestic helpers working in Hong Kong.

Ministers of Thailand in Hong Kong

In April, Deputy Prime Minister of Thailand, Mr Somkid Jatusripitak, met with the then CE C Y Leung at Government House to exchange views on issues of mutual concern. The then CE said that Hong Kong and Thailand had long enjoyed close economic and trade ties and built up strong connections in tourism, culture and education. The then CE-elect Carrie Lam also met with the Deputy Prime Minister to exchange views on issues of mutual concern. She also thanked the Deputy Prime Minister for Thailand's support in Hong Kong's free trade agreement negotiations with ASEAN.

In January, Vice Minister for Finance of Thailand, Mr Kiatchai Sophastienphong, joined the panel in the plenary session on "Asia: Driving Change, Innovation and Connectivity" of the Asian Financial Forum 2017 in Hong Kong. The then SFST Professor K C Chan chaired the session during which he exchanged insights with panellists on Asia's prospects as well as the implications for sustainable global economic development. Professor Chan also hosted a dinner on Fintech on the same day, attended by, among others, Mr Kiatchai Sophastienphong and Under Secretary of State, Ministry of Economy and Finance of Cambodia, Dr Phan Phalla.

HKSAR 20th anniversary celebration events

The HKETO in Singapore organised and supported a variety of celebration events to mark the 20th anniversary (20A) of the establishment of the Hong Kong Special Administrative Region (HKSAR) between March and November this year in Singapore, Thailand and Cambodia. These events ranged from receptions, business seminars and gala dinners, to orchestral performance, dance drama, visual art and photo exhibitions, and sports events.

Kick-off Event Golden Cangue cum Opening Reception

The unveiling event of the series of 20A programmes was the renowned literary and theatrical work Golden Cangue staged in Esplanade, Singapore by the Perry Chiu Experimental Theatre for March 31 - April 1.

The event showcased Hong Kong's theatrical artists and entrepreneurs to a substantial audience size in Singapore through three shows on March 31 (Friday night) and April 1 (Saturday afternoon and evening). The performance, conducted in Cantonese with both Chinese and English subtitles, allowed non-Cantonese-speaking audience to appreciate Hong Kong's theatrical performance. 



On August 6, the HKETO and the HKTDC in Jakarta hosted a predeparture briefing together with Persatuan Pelajar Indonesia - Hong Kong, a student organisation in Indonesia. Over 200 Indonesian students, who will receive tertiary education in universities in Hong Kong, attended the briefing. The briefing gave students a general idea about living in Hong Kong, including the local lifestyle, climate, transportation and other travel tips, which helped them to get ready for the new environment. They also learnt about various affluent and special features of Hong Kong universities.



HKETO's Visits in Indonesia

The HKETO, the HKTDC in Jakarta and the Indonesia-Hong Kong Business Association conducted a market visit to Surabaya from March 20 to 21. The two-day visit aimed to strengthen Hong Kong's connection in Surabaya and East Java region, and to promote Hong Kong's professional services and its unique advantages as an intermediary under the Belt and Road Initiative. The delegation met with various trade and business counterparts in Surabaya, including East Java Chamber of Commerce and Industry, Importer Association Indonesia and Indonesia Chinese Entrepreneur Association to exchange views on matters of mutual interest. The delegation also hosted a seminar and networking luncheon on "Belt and Road Initiative and Hong Kong as a Business Hub in Asia".

The HKETO and the HKTDC in Jakarta also conducted another market visit and outreach seminar in Bandung from October 4 to 5. During the visit, representatives from the HKETO and the HKTDC established ties with the local government institution. With an aim to explore and promote business opportunities, the delegation also learnt about the industry environment in Bandung by visiting different factories and meeting with the business associations.
