Chief Executive visits Thailand

The Chief Executive,
Mrs Carrie Lam, visited

Mrs Lam delivered a keynote speech on "Inequality in the Era of the 2030 Agenda for Sustainable Development" at the opening of the Ministerial Segment. She shared with participants Hong Kong's experience in promoting social inclusion and environmental protection to achieve sustainable development.

Noting that the successful implementation of the "one country, two systems" principle since Hong Kong's return to the motherland had laid the foundation for the city's continued prosperity and stability, Mrs Lam said that Hong Kong would seize the opportunities brought about by the Belt and Road Initiative and strive to promote economic development, which she stressed should be inclusive and beneficial to all.

BILATERAL EXCHANGES

On the same day, Mrs Lam attended a lunch hosted by the Deputy Prime Minister of Thailand, Dr Somkid Jatusripitak, to exchange views on strengthening co-operation between Hong Kong and Thailand. They also discussed the establishment in Bangkok the third Hong Kong Economic and Trade Office (HKETO) in the Association of Southeast

Asian Nations (ASEAN) region raised in her maiden Policy Address in 2017. Both of them were glad that preparatory work was making good progress and hoped that the Office could commence operation early next year.

The Chief Executive also met with the Head of the China delegation to the 74th session of ESCAP, Mr Zhang Jun, during the visit. She expressed her gratitude to the Central Government for its support for Hong Kong's participation as an associate member in the annual session of ESCAP and related work over the years.

Financial Secretary visits the Philippines

The Financial Secretary, Mr Paul Chan, visited Manila, the Philippines from May 3 to 5 to attend the 51st Asian Development Bank (ADB) Annual Meeting. During the visit, he met with the Secretary of the Department of Economic Affairs of the Ministry of Finance of India, Mr Subhash Chandra Garg, and the President of the ADB and Chairperson of the ADB's Board of Directors, Mr Takehiko Nakao. They exchanged views on the economic prospects of Asia, and how Hong Kong could make good use of its strengths as an international financial centre to further collaborate with the ADB in areas such as project investment and financing.

Mr Chan also made a courtesy call on the Ambassador of the People's Republic of China to the Philippines, Mr Zhao Jianhua, and attended a business luncheon hosted by the Hongkong Chamber of Commerce of the Philippines Inc.







Hong Kong Hosts Third Belt and Road Summit


The third Belt and Road Summit, themed "Collaborate for Success", was held at the Hong Kong Convention and Exhibition Centre on June 28. The event, jointly organised by the Hong Kong Special AdministrativeRegion(HKSAR)Government and the Hong Kong Trade Development Council (HKTDC), drew leading speakers from Hong Kong, the Mainland of China, and countries along the Belt and Road, who shared insights on the development of the initiative, intergovernmental cooperation and business opportunities for different industries.





Close to 5,000 participants, including ministerial officials, business leaders and professionals from 55 countries and regions attended the third Belt and Road Summit, at which over 500 one-to-one business-matching meetings with over 220 projects were arranged to promote business deals.

The Summit started with the Chief Executive, Mrs Carrie Lam, delivering an opening address. She said wide participation from different parts of the world is important for the successful implementation of the Belt and Road Initiative, as its pursuit requires a high degree of co-operation between countries and the



establishment of a sound bilateral and multilateral mechanism, as well as participation from different sectors. Mrs Lam added that Hong Kong, being the world's freest economy and China's most international city, is destined to play a significant part in the Belt and Road Initiative.



The Financial Secretary, Mr Paul Chan, delivered opening remarks at the luncheon plenary. The session consisted of a ministerial dialogue chaired by the Secretary for Commerce and Economic Development, Mr Edward Yau, with the participation of four overseas ministerial officials.

Mrs Lam took the opportunity to meet with a number of senior officials who were visiting Hong Kong for the Belt and Road Summit on June 27 and 28. Among them were the Deputy Prime Minister of Thailand, Dr Somkid Jatusripitak, who delivered a keynote speech at the Summit on June 28; and the National Security Advisor, Union Minister for the Ministry of the office of the Union Government and Chairman of the Myanmar Investment Commission, the Republic of the Union of Myanmar, Mr U Thaung Tun, who led a delegation to attend the Summit.

Mrs Lam thanked them for the staunch support for the Summit and exchanged views with them on future cooperation in the context of the Belt and Road Initiative.

During his visit to Hong Kong, Dr Somkid also met with Mr Paul Chan, visited the Hong Kong — Zhuhai — Macao Bridge, Hong Kong University of Science and Technology, and Cyberport.

Hong Kong Chinese Orchestra's concert in Singapore


Summer interns' gathering in Singapore and Indonesia

The HKETO in Singapore hosted a gathering on the evening of July 27 for more than 60 higher education students interning in Singapore under various internship programmes this summer. 45 of them joined the 2018 ASEAN Internship Scheme for Hong Kong Higher Education Students (the Scheme) co-ordinated by the HKETO in Singapore.

The eight University Grants Committee-funded universities in Hong Kong, together with Hong Kong Academy for Performing Arts, Hong Kong Shue Yan University and Hang Seng Management College, are covered by the Scheme. Students of these institutions have responded positively to the internship opportunities offered. About 720 students have joined the Scheme since 2014, taking up internships at private companies, international organisations, academic institutions, think-tanks, arts and cultural organisations, as well as government organisations in the region.


The student interns seized the opportunity to share with their new friends challenges faced and insights developed during their internship in Singapore.

Hong Kong • Talent Hub Unlimited Opportunities

The HKSAR Government promulgated on August 28 the first Talent List of Hong Kong. Aiming to attract talent from around the world in a more focused manner to support Hong Kong's development as a high-value added and diversified economy, the Talent List has been drawn up after extensive consultation with the stakeholders.

The Talent List highlights 11 specific professions needed most for Hong Kong's economic development. They are:

- Asset Management Professionals
- Fintech Professionals
- Actuaries
- Marine Insurance Professionals
- Data Scientists & Cyber Security Specialists
- Innovation and Technology Experts
- Naval Architects
- Marine Engineers & Superintendents of Ships
- Creative Industries Professionals
- Dispute Resolution Professionals & Transactional Lawyers
- Waste Treatment Specialists

Immigration facilitation is provided to eligible persons under the Talent List through the Quality Migrant Admission Scheme (QMAS) within its existing annual quota of 1,000. Successful applicants under the QMAS are not required to have secured an offer of local employment for settlement in Hong Kong. For applicants who meet the specifications of the respective profession under the Talent List, bonus marks will be given under the General Points Test of the QMAS. The Talent List will be regularly updated to ensure that it can keep up with Hong Kong's latest economic development and the changing needs for different talents.
