#### Excerpt of Chief Executive John Lee's keynote speech at the business dinner

The Chief Executive (CE) Mr John Lee led a high-level delegation comprising five senior officials and over 20 prominent business leaders in his trip to three countries of Association of Southeast Asian Nations (ASEAN) in July 2023. In the first stop of Singapore, he attended a breakfast meeting hosted by the Deputy Prime Minister and Minister for Finance, Mr Lawrence Wong, followed by a meeting and lunch hosted by the Prime Minister, Mr Lee Hsien Loong. CE highlighted that Singapore has consistently been HK's largest trading partner in ASEAN, and competition and collaboration come hand in hand in a closely-connected global economy today. Both cities would continue to be active partners in playing a leading role to help advance regional developments. CE also thanked Singapore for supporting Hong Kong's accession to the Regional Comprehensive Economic Partnership (RCEP), adding that HK stands ready to engage in discussions with RCEP members to lay the groundwork for formal negotiations. Addressing about 200 prominent government officials and businessmen in a business dinner, CE highlighted HK's unique advantages under "one country, two systems" and the latest opportunities in Hong Kong.

Mr Lee thanked ASEAN member states for supporting HK's accession to the RCEP, and looked forward to maintaining close communication with the ASEAN Secretariat on relevant issues.

Enterprises and institutions of HK and Singapore signed 7 memoranda of understanding (MoU) on areas including trade, financial services, fintech, innovation and technology, and research collaboration during CE's visit.



The delegation visited a major Singaporean enterprise Meinhardt, noting that its success in using Hong Kong as a springboard to tap the Mainland market could inspire other Singaporean and ASEAN enterprises to follow suit.





The Chief Executive has built friendship and communication with the leaders of 3 countries, and established communication with the Secretary-General of ASEAN;



A total of **33** MOUs and agreements were signed, covering trading and commerce, investment, finance, innovation and technology, logistics, academic research and cultural exchange.



Singapore, Indonesia and Malaysia have reaffirmed their support to HK's accession to the RCEP.



HK and Singaporean governments have agreed to reconvene within this year the civil service exchange programme suspended during the pandemic.




### Secretary for Innovation, Technology and Industry visits Singapore

The Secretary for Innovation, Technology and Industry, Professor Sun Dong, visited Singapore in May. He visited the National University of Singapore (NUS) and learned the university's efforts to bring researches to application and commercialisation. He then toured the Centre for Quantum Technologies and the Mechanobiology Institute. He met with Deputy Prime Minister and Coordinating Minister for Economic Policies of Singapore, Mr Heng Swee Keat, and briefed him on Hong Kong's latest developments in innovation and technology (I&T). Professor Sun also joined a business luncheon attended by some 100 leaders and executives from the Singaporean I&T community, and took the opportunity to share Hong Kong's vision in the relevant sectors. He also called on the Minister for Communications and Information, Mrs Josephine Teo, to exchange views on data, artificial intelligence, and smart city. In his last stop, he toured JTC Corporation's One-north, a vibrant research and business park with leading companies in biomedical sciences and advanced manufacturing as well as science and research institutes.

# Secretary for Housing visits Singapore

The Secretary for Housing, Ms Winnie Ho, led a delegation from the Housing Bureau, Housing Department, HK Housing Authority and HK Housing Society to visit Singapore in August. She met with the Minister for National Development of Singapore, Mr Desmond Lee, and learned Singapore's overall land use planning, development strategies and direction. To deepen the understanding of Singapore's green age-friendly home and construction building, technologies, the delegation toured the Tiong Bahru Market, Punggol Eco-Town, SkyVille@Dawson, Kampung Admiralty, as well as projects adopting Modular Integrated Construction (MiC). Ms Ho was pleased to share with Building and Construction Authority's CEO Mr Kelvin Wong that among public housing projects to be completed in 2028-29 to 2032-33 in HK, no less than half would adopt the MiC approach to enhance construction efficiency, quality and site safety. Ms Ho also called on the CEO of the Housing & Development Board (HDB) of Singapore, Mr Tan Meng Dui.

# Secretary for Security visits Vietnam and Singapore

The Secretary for Security, Mr Tang Ping-keung, visited Vietnam and Singapore in August to strengthen collaboration and exchanges in immigration matters, national security, crime prevention, and prison management and rehabilitation services. In Vietnam, Mr Tang witnessed the signing of a Memorandum of Understanding (MOU) by the Director of Immigration, Mr Au Ka-wang, and the Director General of Immigration Department of Vietnam, Mr Pham Dang Khoa, on enhancing co-operation in immigration matters. He also met with Deputy Minister of Public Security of Vietnam and Senior Lieutenant General, Mr Luong Tam Quang, as well as heads of the Department of External Security, the Department of Homeland Security and the Department of Foreign Relations, exchanging views on anti-terrorism and safeguarding national security. In Singapore, he called on the Senior Minister of Singapore, Mr Teo Chee Hean, and met with the Permanent Secretary (National Security and Intelligence Coordination), Mr Leo Yip. In the meeting with the Minister for Home Affairs and Minister for Law, Mr K Shanmugam, they discussed training of and exchanges between the disciplined forces in the two cities, as well as combating drugs, to explore further room for co-operation. He also shared views on talent attraction initiatives and related visa facilitations with Minister for Manpower, Dr Tan See Leng. In another call on Commissioner of the Singapore Police Force, Mr Hoong Wee Teck, Mr Tang expressed hope for enhancing professional capabilities together. He also visited the INTERPOL Global Complex for Innovation to learn more about its innovative and advanced solutions in combating cybercrimes. Accompanied by the Commissioner of Correctional Services, Mr Wong Kwok-hing, Mr Tang toured the Changi Prison Complex and Selarang Park Community Supervision Centre to learn about technology applications at local prisons, and how to assist persons in custody in further studies and counselling service. In both Vietnam and Singapore, Mr Tang took the opportunity to meet the local HK communities to learn about their living and aspirations in the two places.



As part of HK Government's efforts to attract foreign talent, the Under Secretary for Labour and Welfare, Mr Ho Kai-ming, delivered a career talk at the campus of National University of Singapore (NUS) in August. Addressing about 100 students at scene, including undergraduate and MBA students from the Business School, Mr Ho shared HK's latest market trends and gave a walkthrough of different talent admission schemes. Professor Ming Wai-kit of the City University of Hong Kong also shared his personal experience to work and live in Hong Kong, and the support given by the government and non-government organisations including Hong Kong Quality And Talent Migrants Association to new migrants. Mr Ho highlighted that recent talent attraction effort was bearing fruit - as of end-July, around 120 000 applications had been received under various talent admission schemes, with over 75 000 approved and over 38 000 people arriving in HK. Of which, 30 000 applications had been approved under the newlylaunched Top Talent Pass Scheme (TTPS), including about 270 friends from NUS and Nanyang Technological University, two of the world's top 100 universities. One merit of TTPS is the exemption of the need to first secure a job offer before coming to HK. It consists of three categories:



# Shipping Registry and Investment Promotion teams join two maritime expos

Our dedicated Shipping Registry and Investment Promotion teams joined forces to promote HK's status as a maritime services hub in two large-scale maritime expos in the region, Vietnam Marine & Offshore Expo 2023 (VMOX) held in Hanoi in July, and Indonesia Marine & Offshore Expo (IMOX) held in Batam in August. An exhibition booth was staged in both fairs to engage industrv stakeholders from various maritime fields, from shipbuilding, ship leasing to engineering and arbitration. Speaking at the seminars at both fairs, Regional Head of Shipping Registry, Mr Philip Ho, shared Marine (MD)'s HK Department longstanding reputation with over 150 years of experience in ship registration, inspection and survey.

### As the world's 4th largest shipping register, the HK Flag is noted for its quality, high compliance with safety standards and low detention rate at ports. He encouraged the industry to use the Marine Department's one-stop portal (https://ebs.mardep.gov.hk) and its online fee calculator for ship

registration and certification.

Head of Business and Talent Attraction/ Investment Promotion, Mr Melvin Lee, in another seminar at VIMOX, introduced the myriad of maritime services in HK and how the city's ecosystem of 900 maritime services companies provides support to the global maritime industry. He also highlighted the tax concessions (i.e. a tax rate of 8.25 per cent) for qualifying profits derived from ship leasing management activities. As the most established maritime expos in the region, VIMOX and IMOX together international brought an congregation of maritime practitioners. The former drew 77 exhibitors and close to 2000 visitors, while the latter drew 210 exhibitors and around 5200 visitors this vear.
